Brian Briggeman, Professor, Director of Arthur Capper Cooperative Center, Kansas State University Department of Agricultural Economics

The U.S. economy is in a protracted period of growth that recently has seen improvements to consumer spending and a more robust labor market. While at the same time, U.S. agriculture is in an extended slump. Many producers have been hurt by slowing global economic growth, disruptions to trade, and gradual increases to interest rates. This session will examine recent developments involving the trade of agricultural goods and products on the agricultural sector in general and on Kansas producers specifically. What has been the impact of NAFTA and what is projected for the renegotiated NAFTA and the U.S./Mexico/Canada trade negotiations? China trade issues will also be addressed.
