



## **Rural Law Practice Grant PROGRAM INFORMATION**

The Kansas Farm Bureau Legal Foundation Rural Law Practice Grant is a \$16,500 grant to help defray the educational costs of law school and to encourage new attorneys to locate their legal practice in rural Kansas. The grant furthers the mission of the KFB Legal Foundation to provide legal information and advocacy to farmer and rancher members, unlocking their potential and improving their quality of life in rural Kansas.

**Who is eligible?:** Law students in the fall semester before their anticipated graduation date, who intend to practice law in rural Kansas, can apply for the grant. Rural Kansas is defined as any county which is not one of the top 5 most populous counties in Kansas (*i.e.* not Johnson, Sedgwick, Shawnee, Wyandotte, or Douglas Counties).

**How to apply:** Applicants should complete the application and submit it along with a résumé, transcript and letter of recommendation, during the fall semester before their anticipated graduation date.

**Deadline to apply:** Applications for the grant are accepted on and between September 1 and November 1 of an applicant's final fall semester before their anticipated graduation date.

**Details of grant award:** Up to three (3) grant recipients will be selected each year. Grant selections will be at the discretion of The Kansas Farm Bureau Legal Foundation board, and will be based on completed applications received during the application period. Among other criteria, The Kansas Farm Bureau Legal Foundation board will be looking for applicants who can demonstrate a strong desire to live and work in rural Kansas, an understanding of the legal issues commonly faced by farmers and ranchers in rural Kansas, high academic achievement, as well as financial need. A copy of the evaluation rubric has been included for informational purposes.

Grant recipients will receive payment of the grant in three (3) equal installments. The first \$5,500 installment will be paid when a recipient has graduated, successfully passed the bar examination, and begun the practice of law in rural Kansas. The second and third installments will be paid following proof of recipient's continued practice of law in rural Kansas for 12 and 24 months, respectively.

<ul style="list-style-type: none"> <li>Applicant demonstrated need for additional attorneys in the type of law they anticipate practicing (private v. public, civil v. criminal, etc.) (45 pts max)</li> </ul>

<ul style="list-style-type: none"> <li>Strong letter of recommendation from a persuasive source with experience or knowledge of the applicant's abilities and desires to return to rural Kansas, and / or the need for more attorneys where they intend to practice (40 pts max)</li> </ul>

**REFERENCES** may be checked for the 3 top candidates (after rubric completion by evaluation committee). If there are some reference concerns, additional consideration should be exercised by the evaluation committee before an offer of grant is made.
